

**DECLARATION OF KEVIN McNALLY REGARDING
FEDERAL DEATH PENALTY CASES WITH TWO HOMICIDE VICTIMS**

1. I currently serve as a Resource Counsel with the Federal Death Penalty Resource Counsel Project, assisting court-appointed and defender attorneys charged with the defense of capital cases in the federal courts. I have served as Resource Counsel since the inception of the Resource Counsel Project (RCP) in January 1992. The Project serves as a national clearinghouse for information concerning federal capital cases. The project is funded and administered under the Criminal Justice Act by the Defender Services Office of the Administrative Office of the United States Courts.¹

The responsibilities of Federal Resource Counsel include the monitoring of all federal capital prosecutions throughout the United States in order to assist in the delivery of adequate defense services to indigent capital defendants in such cases. This effort includes the collection of data on the initiation and prosecution of federal capital cases.

3. In the course of regularly conducted activities, the Project maintains a comprehensive database of federal death penalty prosecutions and information about these cases. The Project accomplishes this by reviewing dockets and by downloading and obtaining indictments, pleadings of substance, notices of intent to seek or not seek the death penalty, reviewing public records, and by regularly conducted email, telephonic or in-person interviews between Resource Counsel and defense counsel, and consultation with clerk's offices and judge's chambers. This information is regularly updated and is checked for accuracy.

4. The Project's information regarding federal capital prosecutions has been relied upon by the Administrative Office of the United States Courts, the Federal Judicial Center, and by various federal district courts. Declarations based upon the data collected by the Project have been accepted, cited to and relied upon in numerous opinions and judgments.²

5. The data collected by the Project has also been relied upon as basis for analysis in law review journals, training manuals, and other published material.³ Resource Counsel collect comprehensive, accurate data concerning various practices that have emerged since the federal courts resumed trying capital cases in 1990. This collection of data includes maintaining information concerning district-level practices.

6. The Project maintains data concerning federally charged death-eligible cases where there are two homicide victims. The data below reflects all such cases that, as of October 31, 2021, were completed, *i.e.*, by that date, either the Attorney

General declined to authorize or withdrew authorization seeking the death penalty or, if the case was and remained authorized, it was resolved by trial or guilty plea and, if there was a capital conviction, sentence was imposed.

7. Detailed data on each such case, on which this declaration is based, is contained in the attached Appendix.

8. From data collected, the Project has identified 582 such completed cases, *i.e.*, 582 defendants who faced such death-eligible charges for the homicides of two victims. Of these, 282 were Black (48%), 58 White (10%), 217 Hispanic (37%); and the remainder of “Other” race or ethnicity (*i.e.*, Asian, Native American, or Middle Eastern). (Table 1).

9. The Attorney General authorized 92 of the 582 death-eligible defendants with two homicide victims (16%). Of the 92 defendants, 56 were Black (61%), 17 White (18%), 15 Hispanic (16%), and four “Other.” (Table 1).

10. Of the 92 defendants authorized for capital prosecution, 12 were sentenced to death. Of these 12, seven were Black (58.33%), three were White (25%), one was Hispanic (8.33%), and one was “Other” (8.33%). (Table 1).

11. The data collected by the Project also reveal the race of both victims in the 92 authorized cases, and in 479 of the 490 cases not authorized, *i.e.*, in 571 of the 582 total death-eligible cases involving two homicide victims.

12. Among these 571 cases, 92 (16%) had at least one White victim; of the remainder, 248 (43%) had a Black victim or victims, 207 (36%) had Hispanic victims, and 24 (4%) had victims of “Other” race or ethnicity. (Table 2).

13. Among the 92 cases where the government sought death, 31 had at least one White victim (34%); of the remainder, 41 had a Black victim or victims (45%), 16 had Hispanic victims (17%), and four cases had victims of “Other” race or ethnicity (4%).⁴ (Table 2).

14. Again, death sentences resulted in 12 of these 92 authorized cases.

Of the 12, 8 (67%) had at least one White victims; and of the remainder, 2 (17%) had one or more Black victims, one (8%) had Hispanic victims, and one (8%) had Native American (“Other”) victims. (Table 2).

15. Of the total of 571 two-victim cases in which the race of both victims is known, 39, or 7%, had a Black defendant and one or more White victims. The government sought death in 17 of these Black-on-White cases, representing 18% of all 92 authorizations. And juries imposed death in 5 such Black-on White cases, which constituted 42% of all 12 death sentences. In other words, for a Black-on-White case, the likelihood of authorization was 44% (17 of 39), and the ultimate likelihood of a death sentence was 13% (5 of 39). (Table 3).

16. Of all these Black-on-White cases, 25 had a Black male defendant and at least one White female victim. The government authorized 16 (64%) of those. And juries imposed death in 4 (16%). By comparison, among the other two-victim homicide cases, there were 60 Black-male-on-*Black* female ones, of which 12 (20%) were authorized, and none (0%) ended in a death sentence.⁵ (Table 3).
